Message from the Immediate Past Chair

During those years, CPPPH helped the wellbeing committees of hospital medical staffs with education programs, information and supportive networking. It is rewarding work, and I expect to continue it and expand the focus from hospital medical staffs and medical groups to county medical societies, specialty societies and their Foundations because those are the avenues that can reach all the physicians in our state.

In 2016, the workshop “Effective Functioning of Wellbeing Committees” covered the basic body of information recommended for hospital medical staffs and medical groups.

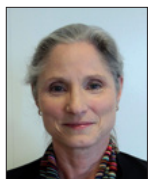
In 2017, CPPPH plans a Certificate of Completion for medical staff services professionals who complete the program, similar to the certificates given in 2014 and 2015 for those who completed the CPPPH program on conducting and reporting evaluations of health care professionals. These activities are built upon the work done in 2014 and 2015 when CPPPH awarded a Certificate of Completion to those who completed its programs on conducting and reporting evaluations of health care professionals.

Legislation

CPPPH’s original mission was to work toward establishment of a statewide physician health program similar to those in 48 of the 50 US states and to support our partner organizations as they sought the necessary legislation. In 2016, the passage of SB1177 authorized the Medical Board of California to create a Physicians and Surgeons Health and Wellness Program “for the early identification of, and appropriate interventions to support a physician and surgeon in his or her rehabilitation from substance abuse.” (See a full copy of the legislation [HERE](#).) The legislation requires that the Program comply with the Uniform Standards Regarding Substance-Abusing Healing Arts Licensees or “the 1441 Standards.” (See a full copy of the Uniform Standards [HERE](#).)

The next steps are for the Medical Board to write the regulations that will govern the program and to issue a request for proposal from all those who will bid to become the administering entity for the program that the regulations describe.

Guidelines

CPPPH guidelines are consensus documents representing expert opinion. Each has followed the same steps of development that include circulation to all interested parties with a request for review and comment. All comments are considered before the document is made final. The guidelines adopted by the Board as CPPPH documents are posted on the CPPPH website, available to all at no cost.

▲ Behaviors that Undermine a Culture of Safety: Policies and Procedures for Medical Staffs and Medical Groups (draft circulating for review and comment)

Intended for those in medical staffs, medical groups, and other entities who evaluate a practitioner's behavior and/or compliance with the organization's code of conduct, this document is designed to assist in the implementation of procedures that maintain the culture of safety and professionalism within the medical staff and the medical center.

▲ Assessing Late Career Practitioners: Policies and Procedures for Age-based Screening

The document is designed for those making policy decisions about age-based screening. It does not advocate in favor of or against mandatory or permissive age-based screening, nor is it intended to replace the judgment of decision-makers applied to individual circumstances. It describes guidelines and principles and provides specific and detailed information about the evolution and impact of age and disability discrimination laws on the options available for evaluating physician competency.

▲ Evaluations of Health Care Practitioners

Health care personnel constitute a special population with licensing and privileging issues connected to their personal health because personal health may impact their ability to practice medicine safely. Evaluations of an individual's personal health are sometimes necessary before decisions about privileging can be made appropriately. Those who request an evaluation should be able to provide a standard compendium of information and expectations to the evaluator. Those who conduct evaluations should have specific qualifications. The report of the evaluation itself should contain standard and sufficient information to support the necessary decisions. This guideline describes these elements in detail. Everything described may not be needed for every evaluation. The information in this document is designed to assist in determining what is indicated for a particular situation.

▲ Selecting Physician Health Services

The information in this document is intended to help make informed choices among providers of services such as intervention, treatment, case management, monitoring. It does not give a list of service providers; it reviews criteria and guidance for carrying out the due diligence routinely employed in making such a selection.

Its services should be available to assist the citizens of California, the regulatory board, associations, hospitals, clinics and individual physicians. California's ideal physician health program (PHP) should identify, provide, or support clinically-based health services for physicians with physical, mental health or addiction issues which, if undetected or not appropriately treated and monitored, could compromise the physician's ability to practice medicine safely.

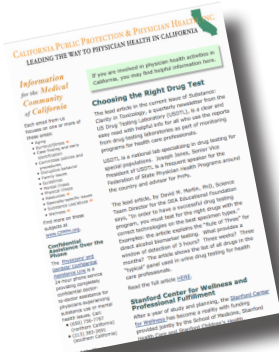

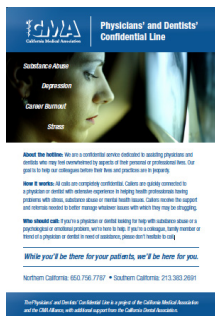
