Dr. SM -- an 48 year old internist whose temper and sarcasm have generated complaints and who has begun to make derogatory comments in her notes in patient records

Dr. CF – a 71 year old urologist whose orders have been uncharacteristically confused or incorrect

Dr. DW – a 39 year old pediatrician who has been unavailable to nursing staff while on call, leading to multiple complaints
